VENDOR APPLICANT TERMS & CONDITIONS

The following Terms and Conditions apply to all vendors participating in the Event who hereby agree to the following with Promote Mexico, LLC dba SCORE International (hereinafter “SCORE”).

Participants are responsible for providing:

- Vendors must be open and ready for business by 4:00 pm on Thursday, September 24, 2015 and closed for business by 9:00 pm.
- Vendors must be open and ready for business by 7:30 am on Friday, September 25, 2015 and closed for business by 2:00 pm.
- Vendors are responsible for all costs, labor, materials, equipment, tenting, supplies, and any other items necessary to operate during business hours.
- Vendors are required to provide trash receptacles and garbage bags.
- Vendors are responsible to bring ample cash and change for transactions. If the vendor accepts credit cards, the vendor is responsible for all equipment and connectivity required.
- Vendors are responsible for their own electricity.
- All **MERCHANDISE VENDORS** must provide a Temporary Sellers Permit issued by the CA Board of Equalization naming the City of El Centro as a temporary business location and a City of El Centro Business License.

Vendor Guidelines & Requirements

- All fees, permits and other required paperwork as indicated on the cover page of this packet must be received upon submission of this application. If your packet is submitted and deemed incomplete, your application will not be processed and is subject to denial.
 - ▶ No credit will be extended _____ initial to acknowledge your agreement
 - ▶ No refunds will be given to those who cancel _____ initial to acknowledge your agreement
- Entries will be processed on a first-come-first-serve basis and all spaces will be assigned by SCORE.
- All items are required to be sold and supervised by the Vendor or staff employed by the vendor in the vendor's assigned area.
- All vendors are responsible to set up their own display, clean up their area and collect and report taxes.
- All vendors are required to remain in their booth area during the hours of the event
- All vendor booths will be inspected before the event start time and may be rejected for noncompliance.
- All signage and decorations must be approved by Score International.
- The Event is outdoors and therefore subject to inclement weather conditions. **All fees are non-refundable.**
- All vendors shall obtain at their own expense all licenses and permits required for operation, including but not limited to licenses and permits required by the State of California, the City of El Centro. etc.
- All vendors are prohibited to sell the following causing general public complaints, and/or extraordinary clean-up: silly string, confetti eggs, spray stink and the like.
- No outside entertainment (example: bands, karaoke, singers, radios, etc.) will be allowing in your assigned vendor area or immediate surrounding area unless approved in writing by Score International.

Insurance, Release, Waiver, Indemnity and Assumption of Risk

All vendors shall provide and maintain during the term of this agreement a combined single limit comprehensive public liability and products liability policy with liability limits in the sum of no less than one million dollars (\$1,000,000.00) The policy be endorsed to provide the following: (1) Promote Mexico, LLC. dba Score International, its officers, agents, employees, sponsors and volunteers (collectively the “**SCORE Parties**”) shall be named as additional insured under the policy; (2) the policy shall operate as primary insurance: (3) subrogation shall be waived against the additional insureds. A signed and complete certificate of insurance shall be submitted to Score International with the vendor application and vendor fees.

By participating in the Event, the vendor and its employees, staff, agents, representatives, and/or affiliated parties (collectively the “**VENDOR Parties**”) are fully aware and understand the potential risks involved with participation in this event which will be conducted in any and all weather conditions and at or near hazardous machines and activities. Specific dangers include without limitation damage and loss to personal property, serious physical injury or death.

As a participant in the Event, I on behalf of myself and VENDOR Parties hereby waive any and all rights and claims for liability or damages, in any form or fashion, that arise out of, relate to or are connected with the Event, against the SCORE Parties. I, on behalf of myself and VENDOR Parties, hereby agree to defend, indemnify and hold the SCORE Parties harmless from and against any and all claims, liability, injuries and/or damages, in any form or fashion, that arise out of, relate to or connected with my participation in the Event or the participation of any VENDOR Parties.

SCORE Owns the Exclusive Right to Use My Name and Likeness as Obtained From This Event.

I and the VENDOR Parties, to include without limitation any business entity or organization with which I am affiliated, hereby irrevocably grant to SCORE and its affiliates, and each of their licensees, successors and assigns, and each of the authorized photographers, videographers and media acting on their behalf, without additional compensation, the unrestricted right to use and copy any audio or video recordings, photographs or film I make, or cause to be made that arises out of, is connected with or related to the Event, and to videotape, film, portray and photograph myself and the VENDOR Parties and our actions and to record our voices and other sound effects while we are present at or around the Event. I, on behalf of myself and the VENDOR Parties, irrevocably grant to SCORE and its affiliates the exclusive right to use our name, image, likeness, voice and biography as well as the voices and images capturing the display area and related staff efforts for any purpose and in any manner, including, without limitation, in connection with the distribution, advertising, promotion, commercial tie-in or other ancillary exploitation of the Event, and any entertainment programming related thereto, in whole or in part, in all media and by all means now known or hereafter devised and in all languages, throughout the universe in perpetuity.
