



**HOW TO SIGN WAIVERS AND RECEIVE YOUR WRIST BAND
WITHOUT ATTENDING ON-SITE REGISTRATION**

We encourage all race participants to complete their registration, purchase memberships, and make payments online. If you do these items online you are eligible to submit a notarized Race Participant Waiver form and reduce the need to attend on-site registration. **If you have a scheduling conflict and cannot make the Registration Check-In these steps are important as there are no late check-ins permitted on race day.** The added benefit of completing all these steps is you can avoid long lines and wait times at on-site registration if completed prior to the mailing deadline (see details below). Registration Check-In dates on Race Week outlined below for the 53rd SCORE Baja 1000:

October 30th	Friday	5PM	Deadline for Notarized Waiver to be received via US mail
November 17th	Tuesday	2PM-8PM	All Teams
November 18th	Wednesday	8 AM-4PM No walk-in entries after 3PM	All Motos, Quads, UTVs & other listed vehicles on the Schedule of Events MUST Tech today and must be banded before entering Tech & Contingency.
November 19th	Thursday	8AM-4PM No walk-in entries after 3PM	All Teams that have not completed waivers and have not been banded. Teams must be banded before entering Tech & Contingency. All racers must be banded by Thursday, November 19 th 4PM to compete in the race.
November 20th	Friday	3:15 AM Staging for Motos/Quads 8:45 AM Staging for all Vehicles	RACE DAY! Absolutely no Registration of any team member allowed on this day.

Here are the required steps for a Driver or Rider of Record to receive their wristband with submission of a Notarized Race Participant Waiver:

IMPORTANT: The Race Participant Waiver must be the version with the revised date of 07.30.20 to be accepted.

1. Have purchased a 2020 SCORE Membership sometime this year.
2. Entry completed and is paid in full for the 53rd SCORE Baja 1000. Anyone withdrawing after bands are mailed must immediately return bands for withdraw to be processed.
3. Print the Race Participant Waiver off the website (must be the revised date 07.30.20 version) and take it to a Notary.
4. The Notarized Race Participant Waiver can be delivered to the Registration Director in one of two ways: A) Have it mailed to 465 S. Meadows Parkway Suite 6, Reno NV 89521; MUST be received no later than October 30th 5PM, or B) a teammate bring it to the Racer Registration Check-in prior to the deadline Thursday, November 19, 2020 4PM. Note: all registration requirements listed above must be completed prior to notarized waiver submission. Copies can be emailed to registration@score-international.com but it is the Registration Director's discretion whether to accept or deny submission and releasing band is not guaranteed with an emailed copy. Original must still be submitted.

5. Minors over the age of 16 with a valid driver's license must complete additional paperwork with Parental Consent so contact the Registration Director at 775-852-8907 prior to October 24th, 2020 5PM to find out all documents required. ☐

Important Notes: Any person racing in the Stock UTV classes must submit a notarized "Stock UTV Class Participant Addendum".

6. A Controlled Access Waiver for essential team support members can be submitted early for bands and is not required to be notarized. Limited 4 bands per team entry. Any Minor 16 years or older, must have a notarized Minor Addendum submitted with the CA Waiver, see Controlled Access Policy on our website www.score-international.com > Race Info > 53rd Baja 1000 logo > Controlled Access Policy.

Here are the required steps for a Co-driver, Co-rider, or Navigator to receive their wristband with submission of a Notarized Race Participant Waiver:

IMPORTANT: The Race Participant Waiver must be the version with the revised date of 07.30.20 to be accepted.

1. 53rd SCORE Baja 1000 Entry Fees paid in full at the time of request. It is your responsibility to check with your DOR/ROR if entry fees are paid. ☐
2. Co-driver, Co-rider, or Navigator name must be listed by the DOR/ROR on the entry to honor their registration. Make sure your DOR/ROR or Team Manager has listed you. ☐
3. Have purchased a 2020 SCORE Membership sometime this year. NOTE: This is not a race registration, see step 4 for Registering for the race. ☐
4. **Must have completed** *Co-driver, Co-rider, & Navigator Required Race Registration – 53rd Baja 1000* form online. We use this health information to print your wristband so it is required. Deadline to complete this form is October 30th, 2020 5PM for those submitting the notarized waiver by mail. ☐
5. Print the Race Participant Waiver off the website (must be the revised date 07.30.20 version) and take it to a Notary. ☐
6. The Notarized Race Participant Waiver can be delivered to the Registration Director in one of two ways: A), Have it mailed to 465 S. Meadows Parkway Suite 6, Reno NV 89521; MUST be received no later than October 30th 5PM, or B) a teammate bring it to the Racer Registration Check-in prior to the deadline Thursday, November 19, 2020 4PM. Note: all registration requirements listed above must be completed prior to notarized waiver submission. Copies can be emailed to registration@score-international.com but it is the Registration Director's discretion whether to accept or deny submission and releasing band is not guaranteed with an emailed copy. Original must still be submitted. ☐
7. Minors over the age of 16 with a valid driver's license must complete additional paperwork with Parental Consent so contact the Registration Director at 775-852-8907 prior to October 24th, 2020 5PM to find out all documents required. ☐

Important Notes: Any person racing in the Stock UTV classes must submit a notarized "Stock UTV Class Participant Addendum".

WARNINGS: If any of these steps are not completed you will not receive your wristband nor can it be picked up by a fellow team member; you will have to attend on-site registration.
